

Terms and Conditions of the Private Purchase of OPEX Tokens by Non-US Citizens

Purchase of OPEX Tokens without Node License, a product of **Ophtherium Labs OÜ**

INSTRUCTIONS

Non-US Purchasers (“**Purchasers**”) of OPEX Tokens should review the information in this notice carefully and are required to attest and affirm to the steps and instructions below.

By checking the box indicating you are a Non-US Citizen, you agree to be bound by the terms of this Purchase Agreement, the Private Placement Memorandum, and any other materials provided to you with respect to the Tokens, including, but not limited to, the White Paper describing the OPEX Tokens and the Private Token Sale www.optherium.io (collectively, the “**Offering Materials**”).

In order to purchase OPEX Tokens, the following must be attested to and completed:

Purchaser Questionnaire: Please submit to the Company, by completing and submitting the online form, a completed and signed Purchaser Questionnaire and E-Signature Page.

Token Purchase Agreement: The private offering of the OPEX Tokens (the “**Private Token Sale**”) will take place during July and August 2018 and will continue until a FlexCap of \$42,500,000 is collected. This sale precedes both the Pre-Sale and the Main Sale but includes the same terms as provided in the Purchase Agreement and the Private Placement Memorandum.

Completeness: *An incomplete Purchase Agreement will not be accepted, and as a result, you may not be able to purchase Tokens during the Token Sale.*

All Purchasers will be subject to KYC/AML checks, and US purchasers will be subject to an accreditation procedure.

The KYC/AML checks and accreditation will be performed by IDM Global, Inc., (<https://identitymindglobal.com>) (“**Accreditation Service**”).

All Purchasers will be required to provide supplemental information and documentation, including the following:

- For entity or corporate purchasers:
 - a copy of the applicable organizational and authority documents (e.g. trust instrument, certificate of incorporation, certificate of formation, corporate resolutions, partnership agreement, operating agreement, plan documents, etc.);
 - name and registry code of the legal entity;
 - name and website address of the register;

- recent print-outs of relevant registers;
- first and last name, personal identification code, time and place of birth of the company authorized signatory;
- name, number, date of issue, and name of the issuer of a travel document (passport) of the authorized signatory;
- basis for the right of representation;
- a document, certifying the right of representation;
- details of the actual (ultimate) beneficiary;
- postal address;
- address of the place of business;
- area of activity;
- bank account details;
- contact phone number and e-mail address.

— For natural, individual person purchasers:

- a copy of passport or other government-issued form of identification;
- a selfie-color picture of the individual along with a copy of Passport or other government-issued travel document;
- first and last name;
- time and place of birth;
- personal identification code;
- name, number, date of issue and name of the issuer of a travel document (Passport);
- address of residence;
- address of location at the time of making contact;
- profession or area of activity;
- contact phone number and e-mail address.

Additional Information: The Company may, in its sole discretion, request other information from the Purchaser.
